

Notes on Contributors

Alexandra Bitušíková received a Ph.D. in ethnology/ social anthropology from Comenius University in Bratislava. Since 1991 she has been working at the Research Institute of Matej Bel University in Banská Bystrica as a senior research fellow and in 1993–2000 as the director of the institute. She is the author of *Urban Anthropology: Trends and Perspectives* (in Slovak), a number of publications focused on urban anthropology, post-socialist social and cultural change in Central Europe, identities, minorities, diversity and gender. In 2001–2002 she worked in the European Commission, Directorate General Research, in Brussels. Now based in Brussels, she works as a research program manager at the European University Association and continues working for Matej Bel University in Banská Bystrica in Slovakia as a senior researcher. Her latest research projects include the EU funded projects: ‘Enlargement, Gender, Governance: Civic and Political Participation of Women in the EU Candidate Countries’ (FP5) and ‘Sustainable Development in a Diverse World’ (FP6 Network of Excellence).

Michał Buchowski is a Professor of Social Anthropology at the University of Poznań and of Comparative Central European Studies at European University Viadrina in Frankfurt/Oder. He lectured and was Visiting Professor at the University of Kansas, Humboldt University, Rutgers University and Columbia University. He was a Fellow of the British Council, Fulbright Foundation, Kosciuszko Foundation and the Humboldt Foundation, and worked as a research fellow in the Centre Marc Bloch in Berlin and CNRS in Paris. His scientific interest is in modes of thought and in Central European social and cultural transformations. He has published several books, among them most recently in English *Reluctant Capitalists* (1997), *The Rational Other* (1997), *Rethinking Transformation* (2001), as well as *To Understand the Other* (in Polish); and he is the co-editor of *Poland Beyond Communism* (2001) and *The Making of the Other in Central Europe* (2001). Currently he is working on issues related to the encounter of the free market and democracy with the realities of post-socialist Poland at the grass-roots level in Poland and Central Europe

Hana Červinková received her Ph.D. in anthropology from New School for Social Research in New York (2003). In her research, she focused on the changing institution of the military and its place in Czech society upon

the Czech Republic's entry into NATO (published as *Playing Soldiers in Bohemia: An Ethnography of NATO Membership*, 2006). Červinková has also published articles on post-socialist transformation, cultural memory, anthropology in education and translated anthropological texts from English into Czech. She works and lives in Wrocław, Poland where she teaches anthropology and works as the Director of the International Institute for the Study of Culture and Education at the University of Lower Silesia.

Vytis Čiubrinskas is currently director of the Center of Social Anthropology at the Vytautas Magnus University, Lithuania. He received his Ph.D. from Vilnius University in 1993. From 2002 to 2006 he conducted research in the USA on transmigration and transnationalism among Lithuanian diasporas and repatriates focusing especially on cultural identity, cultural politics and cultural heritage maintenance. He has published numerous books and articles in Lithuanian, his English-language publications include 'Lithuanian Transnationalism: Constructed, Imagined and Contested Identity of the Lithuanian – Americans', in *Beginnings and the Ends of Emigration* (2005), 'Transnational Identity and Heritage: Lithuania Imagined, Constructed and Contested', in Craith, Mairead N., Kockel, Ullrich (eds.) *Communicating Cultures* (2004), and 'Europe, Cultural Construction and Reality' (review article), – *Ethnologia Scandinavica*, (2003).

Christian Giordano, born 1945 in Lugano (Switzerland); Italian citizen. Studies in Bern and Heidelberg; 1973 Ph.D. in Sociology, University of Heidelberg; 1987 Habilitation in Cultural Anthropology and Anthropology of Europe, University of Frankfurt/M.. Assistant Professor of Cultural Anthropology 1980–86, University of Frankfurt/M. 1988–89. Associate Professor of Sociology, University of Munich. Since 1989 Full Professor of Social Anthropology at the University of Fribourg (Switzerland). Doctor honoris causa of the University of Timișoara (Romania). President of Ethnobarometer, International Research Network on Minorities and Migrations, Italian Council for the Social Sciences; Rome. President of the Interfaculty Institute of East and Central Europe, University of Fribourg. Member of the Evaluation Pool, European Science Foundation. Publications: *Die Betroffenen der Geschichte. Katarína Košťálová studied at the Constantine the Philosopher University in Nitra, Slovakia and specialises in ethnology, social anthropology and folk culture. She carried out research on cultural transformations of the Zvolen region at the Museum in Zvolen, Slovakia. Nowadays she conducts her fieldwork at the Research Institute of Matej Bel University in Banská Bystrica focusing on study of social and professional groups in an urban

environment. She teaches ethnology at the University of Matej Bel. She is a member of the Slovak Ethnological Society.

Grażyna Kubica studied sociology at the Jagiellonian University and specialized in social anthropology. Her fieldwork site is Cieszyn Silesia and Kraków. She is also interested in the history of anthropology, Polish-Jewish relations, nationalism, gender, queer theory and visual anthropology. Her books are: *Lutherans of Cieszyn Silesia*, 1994; the comprehensive edition of Malinowski's diaries, 2002; *Malinowski's sisters, modern women at the beginning of the XX century*, 2006 (all in Polish). She co-edited a volume *Malinowski: Between Two Worlds*, Cambridge 1988 and two others in Polish. She is also a photographer. From 2000 to 2004 she was a member of the Executive Committee of EASA.

László Kürti received his Ph.D. in cultural anthropology from the University of Massachusetts in 1989. He taught anthropology at The American University in Washington DC, and the Eötvös University in Budapest, and presently teaches at the University of Miskolc, Hungary. He conducted fieldwork in North America, Romania and Hungary. His English-language books include: *The Remote Borderland* (2001), *Youth and the State in Hungary* (2002), and served as co-editor for *Beyond Borders* (1996), and *Working Images* (2004). From 2001 to 2006 he served as the Secretary of the European Association of Social Anthropologists.

Rajko Muršič studied ethnology, philosophy (BA) and cultural anthropology (Ph.D., 1998) at the University of Ljubljana. There he teaches basic methodological courses, social structure and popular culture at undergraduate and postgraduate level. He did fieldwork in Slovenia, Poland, Macedonia, Serbia, Germany and Japan. His professional interests comprise methodology of anthropological research, theory and philosophy of science, theory of culture, popular music and anthropology of music, philosophy of music, popular culture and material culture, cultural complexities and transnational studies, and political anthropology. He has published four monographs in Slovene and co-edited MESS: *Mediterranean Ethnological Summer School*, Vol. 3/1999; *Cultural Processes and Transformations in Transition of the Central and Eastern European Post-Communist Countries*, 1999, and Mess, Vol. 5/2003 (all in English, published in Ljubljana).

Terézia Nagy received her MA in ethnology (2002) and sociology (2004) from the University of Szeged. Currently, she is Ph.D. student at Corvinus University in Budapest. She works at the Centre for Regional Studies at Hungarian Academy of Sciences. Her interests include culture of refugees, migrants, homelessness and theoretical approaches of postmodern anthropology and city dwellers. Her articles in English include: "The appearance of an underground electro-music subculture in the cultural

sphere of the city' (2003), 'Conversion and (re)construction of identity – converts in a Hungarian Islam fellowship' (2006).

Peter Skalník (b. 1945) studied in Prague, Leningrad and Cape Town and specializes in political anthropology (state and chiefdom, political culture). He conducted fieldwork in four continents and interests include anthropology of Europe, diplomacy, media and anthropology. He taught social anthropology at Charles University of Prague, Comenius University of Bratislava, University of Leiden, University of Cape Town and presently University of Pardubice. He was an extraordinary professor at University of Wrocław, Poland, in 2005–2007. He was ambassador of his country in Lebanon (1992–1997). His publications (only edited or co-edited books): *The Early State* (Mouton 1978), *The Study of the State* (Mouton 1981), *Outwitting the State* (Transaction 1989), *The Early Writings of Bronislaw Malinowski* (Cambridge 1993), *Sociocultural Anthropology at the Turn of the Century* (Set Out 2000), *Africa 2000: Forty Years of African Studies in Prague* (Set Out 2001), *The Post-communist Millennium: The Struggles for Sociocultural Anthropology in Central and Eastern Europe* (Set Out 2002), *Ernest Gellner: Special Memorial Issue* (Social Evolution and History 2/2, 2004), *Dolní Roveň: počas výzkumu/Dolní Roveň: Research at Half-time* (University of Pardubice 2004), *Anthropology of Europe: Teaching and Research* (Set Out 2005), *Studying Peoples in People's Democracies: Socialist Era Anthropology* (LIT 2005). He is a Vice-President of the International Union of Anthropological and Ethnological Sciences (2003–present).

Gabriel Ionut Stoiciu has a BA (2000) in psychology and sociology from the University of Bucharest. He holds two Master's Degrees: one in Social Anthropology (2001) from the University of Bucharest and another one in Industrial Sociology (2002) from Pierre Mendes France University in Grenoble (France). Presently, he is a Ph.D. candidate at Bucharest University writing his thesis on the anthropology of work. He conducted fieldwork in France and Romania and published several articles in Romanian scientific journals. He is currently employed as junior researcher at the Anthropological Institute of the Romanian Academy.

Zdenek Uherek received his Ph.D. in ethnology from the Czechoslovak Academy of Sciences in Prague in 1992. Between 1993 to 1995 he was a research fellow at the Central European University, Centre for the Study of Nationalism under supervision of Professor Ernest Gellner. Currently, he is a director of the Institute of Ethnology of the Academy of Sciences of the Czech Republic and is chair of the Department of Ethnic Studies there. He is the president of the Czech National Committee of the International Union of Anthropological and Ethnological Sciences, representative of the Czech Republic in the Intergovernmental Council of the UNESCO programme MOST, member of RAI and EASA. He is the first president of Czech Association for Social Anthropology. He teaches at Charles University

(Prague), at the University of West Bohemia (Plzeň) and University of Pardubice. His fields of interest are migration studies, theory of ethnicity, anthropology of Europe, and urban anthropology. He conducted field research in the Czech Republic, Kazakhstan, Russia, Ukraine, Slovakia, Bosnia and Herzegovina and Croatia. His English-language books include monographs: *Aliens or One's Own People: Czech Immigrants from the Ukraine in the Czech Republic* (with N. Valášková and S. Brouček 1997), *Bosnia, Bosnian Czechs, and Migratory Bridges* (with P. Lozoviuk and M. Toncrová 2000). He edited and co-edited publications *Urban Anthropology and the Supranational and Regional Networks of the Town* (1993), *Ethnic Studies and the Urbanized Space in Social Anthropological Reflections* (1998), *Roma Migration in Europe: Case studies* (2004), and *Fieldwork and Local Communities* (2005).
