KIRK BOWMAN is associate professor in the Sam Nunn School of International Affairs at the Georgia Institute of Technology. He is the author of *Militarization, Democracy, and Development: The Perils of Praetorianism in Latin America* (University Park: Pennsylvania State University Press, 2002) and some two dozen articles and book chapters. His forthcoming book focuses on the political economy of tourism promotion in Latin America and the Caribbean. Prof. Bowman has conducted extensive fieldwork in Argentina, Brazil, Costa Rica, Cuba, Fiji, Honduras, and Uruguay. He received his Ph.D. at the University of North Carolina, Chapel Hill in 1998.

JOHN A. BRITTON is Gasque Professor of History at Francis Marion University and was recently named a Francis Marion University Board of Trustees Research Scholar. His publications include *Carleton Beals: A Radical Journalist in Latin America* (Albuquerque: University of New Mexico Press, 1987) and *Revolution and Ideology: Images of the Mexican Revolution in the United States* (Lexington: University Press of Kentucky, 1995). His articles have appeared in the *Hispanic American Historical Review*, *The Americas*, *The Journal of Latin American Studies*, *Journalism History*, the *SECOLAS Annals*, and *Business History Review*. He also serves as a contributing editor to the *Handbook of Latin American Studies*.

GLENN J. DORN is associate professor at Embry-Riddle Aeronautical University. He has published a number of articles on US-Latin American relations in the 1940s, and a monograph, *Peronistas and New Dealers: US-Argentine Rivalry and the Western Hemisphere, 1946-1950* (New Orleans: University Press of the South, 2005). At present, he is working on a study of the Truman administration's response to nationalism and communism in South America during the early years of the Cold War.

ALAN MCPHERSON is associate professor of history at Howard University. He is the author of *Yankee No! Anti-Americanism in US-Latin American Relations* (Cambridge, Mass.: Harvard University Press, 2003), a *Choice* Outstanding Academic Title in 2005 and the winner of the A. B. Thomas Award for best book of the year by the Southeastern Council on Latin American Studies. In 2006, he will also publish *Intimate Ties, Bitter Struggles: The United States and Latin America since 1945* (Washington: Potomac Books). He is also working on a book about resistance movements in Central America and the Caribbean from 1912 to 1934.

JASON PARKER is assistant professor of history at West Virginia University, where he is currently revising his manuscript on Anglo-American-Caribbean relations during the decolonization of the British West Indies. His articles on US foreign relations, transnational race-based activism, and decolonization and the Cold War have appeared or are under consideration in *International History Review*, the *Journal of African American History*, *Diplomatic History*, and the *American Historical Review*. His next project, for which he has received a fellowship from the Smith Richardson Foundation, will examine American Cold War public diplomacy in the Third World.

DARLENE RIVAS is associate professor of history at Pepperdine University and the author of *Missionary Capitalist: Nelson Rockefeller in Venezuela* (Chapel Hill: The University of North Carolina Press, 2002). Her current project explores U.S. efforts to promote economic development through technical assistance programs in Central America in the post-World War II era.

DAVID RYAN is currently a member of the Department of History, University College Cork, Ireland. He is the author of a number of books and articles on US foreign relations including *US-Sandinista Diplomatic Relations* (New York: St. Martin's Press, 1995), *US Foreign Policy in World History* (New York: Routledge, 2000), and *The United States and Decolonization* (New York: St. Martin's Press, 2000). He is currently working on a history of U.S. intervention in regional conflict and collective memory since Vietnam.

JEFFREY F. TAFFET is an assistant professor of history at the United States Merchant Marine Academy at Kings Point, New York. He earned his Ph.D. in 2001 from Georgetown University in the history of US foreign relations. His research focuses on foreign aid programs and US-Chilean relations in the 1960s. He has published articles on Chilean

folk music, Chilean editorial cartoons, and the approach to gender issues among Chilean leftist parties. He is currently working on a book about the Alliance for Progress.

WILLIAM O. WALKER III is professor of history at the University of Toronto. He is the author of two books on drugs and US foreign policy, *Drug Control in the Americas* (Albuquerque: University of New Mexico Press, 1981, 1989) and *Opium and Foreign Policy: The Anglo-American Search for Order in Asia, 1912–1954* (Chapel Hill: The University of North Carolina Press, 1991). He is also the editor of *Drugs in the Western Hemisphere: An Odyssey of Cultures in Conflict* (Wilmington, Del.: Scholarly Resources, 1996). He is working on a book about US-Andean relations since 1960.
